- 1. Call to Order and Agenda Review** – Jakeline De Leon took roll call of the Advisory Council Members before the meeting started to establish a quorum. The meeting was called to order at 9:06AM by Chair Suz Montgomery. Under Agenda Review, Suz announced that 6.1 will be a closed section for the voting of new members.

2. **Pledge of Allegiance** – The Pledge of Allegiance was led by Chair Suz Montgomery.
3. **Approval of Area Agency on Aging Advisory Council Minutes of March 10, 2021** – Karen Gorback provided some feedback for the March 10 meeting minutes and commented that she taught people to write letters and articles.
4. **Public Comments** – No Public Comments.
5. **Consent Agenda Items** – the Transportation Committee Report from March 10, 2021 was approved (Gorback/Gitt/Passed).

DISCUSSION ITEMS/PRESENTATION/MOTION

6.1 VCAAA Nominating Committee Report and Reappointment of One Service Provider and Three Focused Population Seats for FY 2021-2023 – Toni Olson announced that the Nominating Committee met on May 3, 2021, to develop the slate as per their Bylaws. She then announced the slate for the Focused Population seat for caregivers was Maureen Hodge and Marcy Smart; the Focused Population seat representing LGTBQ+ individuals was Ronald Berkowsky; and the slate for the Focused Population seat representing people with disabilities was Carol Leish and Neil Spector. The committee also recommended that Martha Shapiro be reappointed to a 3rd and final term representing service providers. All applicants introduced themselves, spoke a bit of their backgrounds and gave reason as to why they would like to represent those Focused Populations. After introductions, the committee made the motion to accept the slate (Munguia/Gorback/Passed). The results of the election were as follows: Maureen Hodge for the Family Caregivers Focused Population seat, Ronald Berkowsky for LGBTQ+ Focused Population seat and Carol Leish for Disabilities Focused Population seat. Martha Shapiro was also reelected to a 3rd and final term in one of the Service Provider seats.

6.2 Recommendation to Renew FY 2021-2022 Grantee/Contractor Funding and Related Service Categories. – Joaquin presented an overview of the Grantee Renewals. The committee had a couple of questions regarding the meals that were being provided to Ventura County seniors and people with disabilities. Victoria and Joaquin addressed their questions and stated they are working on the logistics to determine the long-term needs and funding post covid. The committee moved to approve the proposed budgets (Sweetland/Olson/Passed). Martha Shapiro, Sylvia Stein, Sue Tatangelo, Lynette Harvey, and Mike Williams all abstained.

6.3 Ratification and Approval of the FY 2021-2022 Strategic Plan Update – Victoria gave a brief update of the FY 2021-2022 Strategic Plan. No comments or

changes were made at the Public Hearing; however, any changes could be made when needed. The committee made the motion to accept the ratification and approval of the FY 2021-2022 Strategic Plan (Tatangelo/Gorback/Passed).

6.4 Recognition of Advisory Council Members Leaving the Council – Monique thanked all Advisory Council members leaving the committee on behalf of all the Advisory Council staff. Marcy Sherbok expressed her appreciation with the committee and being a part of the Advisory Council Board. Lastly, Monique presented a resolution for Volunteer Appreciation Week to the committee and thanked the committee on behalf of the Board of Supervisors.

6.5 VCAAA Covid 19 Response Update and Fiscal Outlook – Victoria provided an overview of the VCAAA Customer Growth, the Services VCAAA provides, and Contracted Services. She and Brian then presented an overview of the FY 2021-2022 Budget. Monique introduced Cruz Silva, VCAAA’s volunteer coordinator and Victoria gave a brief overview of the Covid-19 Response. Victoria announced the partnership VCAAA has with the Library system for the digital devices will be launched in June. Lastly, Victoria updated the committee and stated that overall, there were 4.2 million meals served. This work was completed by 63 plus disaster service workers, 574 plus volunteers and 627 plus employees.

6.6 Older Americans Month, PIO, and Outreach Update – Jannette provided an Older Americans Month, PIO, and Outreach Update. Jannette mentioned that the Fall Prevention Forum in September 2020 had about 6000 views. The Fall Prevention Forum in April 2021 had about 18,000 views. In addition, she mentioned that for Volunteer Appreciation Week, they had weeklong video tributes for our volunteers and Advisory Council Members, acknowledging their contributions to the agency. Lastly, Jannette announced that they have received a resolution from the Board of Supervisors for Older Americans month and skits are being posted every Monday to help seniors on fraud prevention as well as “Friday Focus” are being posted on Fridays.

Rally Day. Over 330 members attended the zoom meeting. Richard Figueroa gave the opening speech and the program was centered on the Master Plan on Aging. Karen then mentioned that she is working on two proposals for CSL, the first proposal has to do with recruitment and training for caregivers. The second proposal has to do with a resolution for the state legislature to take up on Ageism Awareness. She also mentioned that she had an article published on Ventura County Star regarding Ageism Awareness.

- c) VCAAA Foundation Update –** Mike Williams gave a brief update for the VCAAA Foundation. Their flyer is on the VCAAA website. Mike has asked everyone to share the flyer.
- d) LGBTQ Aging Coalition –** Martha gave a brief update on the LGBTQ Aging Coalition. They developed a training that is geared for service providers that are focused on older adults.
- e) Dementia Friendly Ventura County –** Haleh gave a brief update of the Dementia Friendly Ventura County meeting. She announced the initiation of Project LifeSaver.

10. Comments from the Chair – Suz commented that she does not want to lose track of the Mental Health Facility.

11. Other Business – Ari Larson announced that Filmore will be having a NAMI (National Alliance for Mental Illness) walk on Saturday, May 15th at 10 AM at City Hall. She also announced that the mayor of Filmore presented a proclamation to their seniors. Dr. Munguia announced that the mayor of Santa Paula presented a proclamation for Older American Month to their Advisory Council in Santa Paula.

1. **Call to Order and Agenda Review** – The meeting was called to order at 9:04AM by Chair Suz Montgomery. Jakeline De Leon took roll call of the advisory council members. Suz introduced a new member to the Advisory Council, Jeanette Sanchez; she then introduced herself and a bit of her background.
2. **Pledge of Allegiance** – The Pledge of Allegiance was led by Chair Suz Montgomery.
3. **Approval of Area Agency on Aging Advisory Council Meeting Minutes of January 13, 2021** – (Owens/Olson/Passed)
4. **Public Comments** – Karen Gorback announced that Monday, March 15, 2021, at 10:30AM, she will be teaching “Pro’s with a Purpose” at Conejo Valley Adult School. Smita Dandekar announced that she will be conducting a yoga class via zoom for Simi Valley; it is an eight-week class and it is going very well.
5. **Consent Agenda Items** – All committee reports were approved (Gorback/Olson/Passed).

DISCUSSION ITEMS/PRESENTATION/MOTION

- 6.1 VCAAA Nominating Committee Report and Election of Advisory Council Officers for FY 2021-2022 and Reappointment of One (1) Service Provider and One (1) Focused Population Seat for FY 2020-2022** – The motion was accepted to accept the slate as presented by the nominating committee (Tatangelo/Olson/Passed). All committee members were in favor of the slate being reappointed.
- 6.2 VCAAA Nominating Committee Report and Election of (1) Service Provider – Health Care, (1) Consumer Seat, (1) Focused Population Seat – Behavioral Health for a Two Year Term (2021 – 2023) and (1) Seat – Behavioral Health for a Two Year Term (2021 – 2023) and (1) California Senior Legislature Representative for FY 2021-2025.** – Toni Olson presented the nominating committee report which included the following slate:
- Service Provider (Health Care) - Katy Krul and Lynette Harvey
 - Focused Population - Behavioral Health: Peter Schreiner and Ronda Wilkin
 - California State Legislator Seat - Rossanna Guerra
- There were no further nominations. The slate was accepted by all committee members (Sweetland/Sherbok/Passed). The Advisory Council elected Lynette Harvey to the Service Provider (Health Care) for a two-year term and Peter Schreiner to the Focused Population seat for a two-year term and Rossanna Guerra to a four year term as the CSL representative.
- 6.3 VCAAA Covid 19 Response Update** – Victoria gave an update on the VCAAA Covid 19 Response. Overall, VCAAA has hit over 3.5 million meals; closing in on 3.6 million meals served. All meals are being covered by FEMA Funds, the Older Americans Act Funds, the Cares Act funds, and additional funds. The budget is close to 60 million due to all of the efforts. As of now, there are over 50 restaurants participating in VCAAA’s various meal programs. There have been over 50 thousand requests for services. VCAAA has also been working with Human Service Agency and Public Health on vaccinating homebound older adults. The homebound vaccinations began in Piru. It began with the 75 plus older adults and now moving towards the 65 plus older adults. Letters of support are still being sent to VCAAA daily from the community. Lastly, Victoria reported that Google Home Devices have already gone out and been provided to the community. Suz Montgomery will be demonstrating to the community on social media how to use the Google Homes. There have been 500 chrome books purchased as well and are getting ready to go out soon. VCAAA is still working on receiving the Grand Pads.
- 6.4 Recommendation for the Executive Committee to Approve the Planning and Allocation Committee’s Recommendations regarding FY 2020-2021 one-time-only funding from the California Department of Aging.** – The

Advisory Council committee approved this recommendation (Gorback/Williams/Passed).

- 6.5 Recommendation for the Executive Committee to Approve and Make Modifications to the FY 2021-2022 Strategic Plan based on Public Input and Forward to the Ventura County Board of Supervisors for Approval (Due to CDA May 1, 2021).** – The Advisory Council committee approved this recommendation as stated in 6.5 of the agenda (Owens/Williams/Passed).
- 6.6 Long Term Care Ombudsman and Access to Facilities Update** – Sylvia Taylor Stein gave a brief overview of the Long-Term Care Services Ombudsman program and an update through a PowerPoint presentation. Monique will distribute Sylvia's PowerPoint with all Advisory Council members.
- 6.7 Things You Should Know – COVID Rent Rules** – Mike Williams gave an update on the Covid Rent Rules through a PowerPoint presentation.
- 6.8 PIO and Outreach Update** – Jannette gave the PIO and Outreach Update. VCAAA has distributed more than 36 videos to the community from the last year, has distributed more than 160 different flyers over the last year and in January 2021, VCAAA launched the 2021 LiveWell Resource Guide. The VCAAA Foundation has had increased community donations due to the LiveWell Resource Guide. The VCAAA website has been modified and updated. The Letters of Support campaign started in September and it is continuing to this day. VCAAA has received approximately 10 thousand letters. Ongoing, VCAAA has a substantial increase in the amount of presentations both on local and national level. Social media following has increased as well. The latest outreach project is the VCAAA calendar, it is available both in English and Spanish. They include pictures of local residents and information in English and Spanish about different programs that VCAAA offers. Jannette then shared her screen with the committee and demonstrated the VCAAA websites new In Memoriam tab of all Advisory Council members who have passed to memorialize their service. Lastly, Jannette shared VCAAA's latest video collaborating with the County CEO's office, the Human Services Agency, and Health Care Agency to showcase the work that's being done to get the vaccination to home bound seniors.

She announced that 3.4 million individuals in California as of March 5, 2021 have been fully vaccinated. California is also receiving 1.5 million doses per week of the vaccine, however in the next two weeks, the Johnson and Johnson vaccine will not be available for shipment to California. She announced by March 15th, from ages 16-64, they are opening vaccine appointments for individuals with underlining medical conditions. Lastly, she announced that any individuals who are having trouble getting the vaccine may go to the website: www.myturn.ca.gov or call +1(833) 422-4255.

- 1. Welcome and Introductions** – The meeting was called to order at 11:20AM by Carol Martin. No introductions were made.
- 2. Public Comments** – No public comments.
- 3. ElderHelp Transportation Update; COVID Vaccine and Testing Sites** – Jason gave an update on ElderHelp Transportation, COVID Vaccine, and Testing Sites. Jason mentioned that VCAAA is still providing medical rides for the vaccines. Rides are being provided all over Ventura County, to Santa Barbara County and LA County as well. Jason then shared the transit agencies had begun collecting fares again this month of May. Tony then asked Jannette if this information provided by Jason is posted on the VCAAA website. Jannette addressed his question and stated that she will be working with Jason to provide the best verbiage for the website. Monique also shared that VCAAA will be taking care of the Call Center for Older Adults that HSA was running and Jannette will be doing a social media push for it as well. Lastly, Jason added that the COVID vaccines and testing sites are widely available now. He mentioned there are mobile clinics now and the website <https://www.venturacountyrecovers.org/> provides more information.
- 4. Online Trip Ordering Form Update** – Jannette gave an update on the Online Trip Ordering Form. She shared her screen with the committee and

demonstrated the current transportation referral form. Jannette explained that they are working with IT services in turning the current Transportation Referral form to an online request form. The individuals who do not wish to make any requests online will still have the option to contact VCAAA's I&A specialists to help them with the Transportation Referral form. The individuals who wish to complete the form online will be able to go to the VCAAA website and access an online version of the Transportation Referral form. They will then submit the form and VCAAA's I&A team will fulfill this need. Jannette also shared that they are adding a new feature to the online version. She explained that when the individuals add their birthdays, if they are under 60 years old, it will ask for more information to make sure they are eligible to receive a ride. Jannette stated that this online version should be available in 2 weeks. Carol then asked Jannette if individuals will have to complete this form every single time they need a ride. Jason addressed her comment and stated that as of right now with the current transportation referral form, they are given the option to request rides for that month or be on a monthly list. Jannette took note of that and stated that she will be adding that to the online version. Jason then asked Jannette if there is a form in which individuals will be able to upload their ADA card. Jannette addressed his question and stated that she will ask for more information on that. Tony suggested only requesting the number of the ADA card instead of uploading the entire card. Monique agreed with Tony and stated that she will be looking more into that. Jason added that providing only a number may be a bit difficult due to verification from the agency, however they will still find more information on that.

5. **Transportation Program Training Video** – Monique gave a brief update on the Transportation Program Training video. She mentioned that this will be the next project they work on after the Online Trip Ordering form. She stated that they will try to have the video completed before the next meeting in July and if they have any suggestions to please email Jannette.

- 1. Call to Order** – The meeting was called to order at 1:00 pm. A quorum was present.
- 2. Review of Health and Nutrition Goal Matrix and Development of New Objectives**
 - The committee reviewed the draft goal matrix, focusing on goal #5. The committee began their discussion by addressing the digital devices that will be going out to the community. The committee agreed to ensure that all digital devices have Spanish options and the settings are in Spanish as well. Jannette then suggested ensuring that the settings have larger fonts for individuals with low vision. Ongoing, the committee discussed having Spanish and ASL interpreters for the Fall Prevention classes as well as having a bilingual dietitian and a Spanish and ASL interpreter for the Advisory Council Meetings. The committee also addressed the future meetings location. Victoria suggested having hybrid meetings for those who would like to participate remotely, and other committee members can be meeting at one specific location. John Gardner and Toni Olson also suggested having different zoom rooms at different locations as well as recording the zoom meetings and providing the recording on the Advisory Council website. Lastly, goals #1, #2, #3, and #4 were developed by the committee previously with some objectives already having been completed. This list

is not definitive, the committee will continue adding to and refining the goals and objectives over the coming months.
